***Note:**

Candidates will be considered to have forfeited their right as new-student of ITS for the academic year 2026/2027 if:

1. Do not pay the IDF/IPI and Tuition Fee/UKT by **July 21 at 15.00 WIB (GMT+7)**, and/or
2. Do not fill out the personal data and do not upload the required documents by **July 22, 2026 at 23:59 WIB (GMT+7)**

Note:

1. Payment of Institution Development Fee (IDF/IPI) has two options i.e. full payment or installment. IDF and Tuition fee (UKT) payment can be made to the designated bank i.e. Bank BNI, BRI, Bank Mandiri, Bank Syariah Indonesia, BTN, or Bank Jatim across Indonesia, possible payment via teller, ATM, internet banking, and mobile banking.

Exception: new-student candidates with foreign citizens proceed directly to fill out the required data and upload the required documents into SIPMABA. Complete the tuition fee (UKT) payment with special assistance from ITS Finance Bureau.

2. Documents Required for Online Registration:

- a. A recent color passport photo with dimensions of 400 x 400 pixels, with blue background, plain white shirt, and black headscarf for those wearing one, without glasses or any other accessories, in JPG or PNG format, size between 200 and 500 KB.
- b. Scanned documents (JPG or PNG format, size between 200 and 500 KB per document):
 1. High School Diploma or Certificate of Graduation (SKL) or Certificate of Being Enrolled in Grade 12 from school;
 2. High School Academic Report/transcript
 3. Family Card (KK) and National Identity Card (KTP), or passport for foreign student;
 4. Birth Certificate;
 5. Healthcare Insurance Card (if not yet available, it can be arranged during registration);
 6. Statement Letter of Non-Withdrawal of Education Fees (form 1), Statement Letter of Document Falsification (form 2), and Statement Letter of Student

Ethics (form 3) with required stamp duty (meterai) of IDR 10,000 for each letter. Template:
