#### Measures before Entering into Thailand

- 1. Avoid risk-prone areas or crowded places for no less than 14 days
- 2. Apply for the Non-Immigrant Visa Type "ED" at the nearest Thai embassy or Thai Consulate-General office by providing the following documents\*:
  - 1) Copy of Flight Ticket
  - 2) Copy of Reservation Documents for Alternative State Quarantine (ASQ) (reservation/booking at <a href="https://www.hsscovid.com">www.hsscovid.com</a>
  - 3) Copy of Financial Statement Report
  - 4) Copy of Acceptance Letter from MFU
  - 5) Two photographs, size 4 x 6 cm
  - 6) Bank Balance Certificate/Statement
- 3. Apply for the 'Certificate of Entry' (COE) at the nearest Thai embassy or Thai Consulate-General office by providing the following documents\*:
  - 1) Fit to Fly Health Certificate
  - 2) **Medical Certificate** (with a laboratory result indicating that COVID-19 is not detected by RT-PCR technique), issued no more than 72 hrs. Before travelling
  - 3) Copy of Reservation Documents for Alternative State Quarantine (ASQ) (reservation/booking at <a href="https://www.hsscovid.com">www.hsscovid.com</a>)
  - 4) Copy of Flight Ticket
  - 5) **Insurance policy** covering health care and treatment expenses for COVID-19 disease (with a coverage of **no less than 100,000 USD**)
  - 6) Declaration Form
  - 7) Passport (must be valid at least 6-12 months)
  - 8) **Conduct exit screening** for respiratory symptoms and temperature measurement of travelers for fever at Points of Entry at the country of origin before boarding.

Note: Airport check-in: You are required to prepare and show all necessary documents required to the airline

\* The required documents are subject to change anytime and without prior notice.

Consulate General before flying off to Thailand.

#### Measures upon Arrival/during Stay in Thailand

- 1. Conduct entry screening for respiratory symptoms and temperature measurement for fever at Points of Entry before entering into the Kingdom;
- 2. Submit documents to competent officials or communicable disease control officers at Points of Entry;
- 3. Install the "AOT Airports" application prescribed by the government for the surveillance and monitoring of symptoms during quarantine;
- 4. Undergo quarantine and comply with the order of communicable disease control officers at the ASQ for a period of no less than 14 days.
- 5. Undertake COVID-19 diagnostic test by RT-PCR technique twice. The first test shall be taken between days 3 to 5 and the second test shall be taken between days 11 to 13 of the period of quarantine.

- Install the "AOT Airports" application
- Undergo quarantine at the ASQ for a period of no less than 14 days.
- Undertake COVID-19 diagnostic test by RT-PCR technique twice.
