# Visa on Arrival Vs E-Visa on Arrival

**Visa on Arrival** can be applied by foreigners directly when arriving at the arrival airport / port in Indonesia, meanwhile for **Electronic Visa on Arrival (E-Voa)** submission can be done through the website evisa.immigration.go.id prior departure.

Both VoA & E-VoA are available for international students/faculty members who are from 97 selected countries (listed below). Initially, this visa aims to equip the foreigner who comes to Indonesia for tourism purpose. Thus, this visa can only be reserved for international students/faculty members who will take part in the short program at ITS. This visa is valid for **30 days** stay and allowed to be extended for up to 90 days maximum.

Both visa fee are **IDR 500.000** for 30 days stay and **Free** for ASEAN Countries. For VoA, the fee should be paid in cash at the arrival airport/port, while for E-VoA fee should be paid by Credit Card after the online registration.

Some eligible program at ITS Surabaya with this visa:

- 1. Short Program (less than 30 days)
- 2. Short internship (less than 30 days)
- 3. Guest Lecture
- 4. Courtesy Visit
- 5. International Conference
- 6. International Meeting/Summit

# C9 Short Course 60 days

A person who is attending a benchmarking activity, short course, or short training program

### A. Stay

Up to 60 Days (Extendable)

### B. Cost

IDR 2,000,000

# C. Document Requirement

- 1. Passport valid for at least 6 (six) months (for holders of travel documents other than passports such as emergency passports, documents of identity, etc. must be valid for 12 months).
- 2. Personal bank statement with minimum amount USD \$2000 or equivalent the last 3 months period (including name, date of period, and balance account)..
- 3. A recent color photograph.
- 4. Proof of guarantee from the guarantor
- 5. Proof of registration or certificate as a participant in benchmarking activity, short courses, or short training program from government agency or private institution.

- This visa must be used to enter Indonesia within 90 days from the date of issue.
- Please note that the validity period is different from the period of stay, please check your visa for Information on the period of stay.



# C9C Bahasa Indonesia Short Course 60 days

A person who attended a short course or short training related to Bahasa Indonesia

# A. Stay

Up to 60 Days (Extendable)

### B. Cost

IDR 2,000,000

# C. Document Requirement

- Passport valid for at least 6 (six) months (for holders of travel documents other than passports such as emergency passports, documents of identity, etc. must be valid for 12 months).
- Personal bank statement with minimum amount USD \$2000 or equivalent the last 3 months period (including name, date of period, and balance account)..
- A recent color photograph.
- Proof of guarantee from the guarantor
- Proof of registration or certificate as a participant in benchmarking activity, short courses, or short training program from government agency or private institution.

# **Visa Validity**

- This visa must be used to enter Indonesia within 90 days from the date of issue.

# E30B Bachelor Degree Visa 1 Year / 2 Years

A person who plans to enroll for a bachelor's degree in a college, including student exchange program

# A. Stay

Up to 1 Year (Extendable, but based on study period at LoA) Up to 2 Years Extendable, but based on study period at LoA)

### **B.** Cost

US\$150 + Rp2,700,000 (Up to 1 year) US\$150 + Rp3.950.000 (Up to 2 years)

(Note: The visa fee also includes the residence permit /ITAS and Multi Re-entry Permit)

# C. Document Requirement

- Valid Nationality Passport at least 6 (six) months.
- Proof of living expenses of at least US\$ 2,000 (two thousand US Dollars) or equivalent.
- Latest color photograph.
- Guarantee letter from a guarantor, which is an Indonesian citizen or the educational institution where foreigners carry out education.
- Letter of acceptance from the educational institution in Indonesia that explains the length of time the foreigner will be enrolled in the educational institution.

# **Visa Validity**

- This visa must be used to enter Indonesia within 90 days from the date of issue.
- Please note that the validity period is different from the period of stay, please check your visa for Information on the period of stay.

# E30C Master's Degree Visa 1 year/2 years

A person who plans to enroll for a master's degree in a college

# A. Stay

- Up to 1 Year (Extendable, but based on study period at LoA)
- Up to 2 Years Extendable, but based on study period at LoA)

### **B.** Cost

- US\$150 + Rp2,700,000 (Up to 1 year)
- US\$150 + Rp3.950.000 (Up to 2 years)

(Note: The visa fee also includes the residence permit /ITAS and Multi Re-entry Permit)

# C. Document Requirement

- 1. Valid Nationality Passport at least 6 (six) months.
- 2. Proof of living expenses of at least US\$ 2,000 (two thousand US Dollars) or equivalent.
- 3. Latest color photograph.
- 4. Guarantee letter from a guarantor, which is an Indonesian citizen or the educational institution where foreigners carry out education.
- 5. Letter of acceptance from the educational institution in Indonesia that explains the length of time the foreigner will be enrolled in the educational institution.

- This visa must be used within 90 days from the date of issue.
- Please note that the visa validity period of the visa is different from the period of stay, kindly check your visa for the period of stay Information.

# E30D Doctoral's Degree Visa 1 year/2 years

A person who plans to enroll for a doctoral degree in a college

# A. Stay

- Up to 1 Year (Extendable, but based on study period at LoA)
- Up to 2 Years Extendable, but based on study period at LoA)

### **B.** Cost

- US\$150 + Rp2,700,000 (Up to 1 year)
- US\$150 + Rp3.950.000 (Up to 2 years)

(Note: The visa fee also includes the residence permit /ITAS and Multi Re-entry Permit)

# C. Document Requirement

- 1. Valid Nationality Passport at least 6 (six) months.
- 2. Proof of living expenses of at least US\$ 2,000 (two thousand US Dollars) or equivalent.
- 3. Latest color photograph.
- 4. Guarantee letter from a guarantor, which is an Indonesian citizen or the educational institution where foreigners carry out education.
- 5. Letter of acceptance from the educational institution in Indonesia that explains the length of time the foreigner will be enrolled in the educational institution.

- This visa must be used within 90 days from the date of issue.
- Please note that the visa validity period of the visa is different from the period of stay, kindly check your visa for the period of stay Information.

# C22A Academic Internship Visa 180 days

A person who conducts an internship in Indonesia to satisfy the academic requirements of an overseas education

# A. Stay

Up to 180 Days (Extendable, but depends on the internship period at LoA)

### **B.** Cost

• IDR 6,000,000

(Note: This visa is Single Entry Visa, NOT Multi Re-entry Visa)

# C. Document Requirement

- 1. Passport valid for at least 6 (six) months (for holders of travel documents other than passports such as emergency passports, documents of identity, etc. must be valid for 12 months).
- 2. Personal bank statement with minimum amount USD \$2000 or equivalent the last 3 months period (including name, date of period, and balance account).
- 3. Latest color photograph.
- 4. Proof of guarantee from the guarantor
- 5. Internship contract or statement from government agency or private institution as the host of the internship program

- This visa must be used to enter Indonesia within a maximum of 90 days from the date of issue.
- Please note that the validity period of the visa is different from the period of stay, please check your visa for information on the period of stay.



# Additional ITS Administration Fee

# IMPORTANT NOTE

Besides the visa and stay permit fee, ITS Global Engagement will charge the administration fee to international students immigration, residence permit, and also for international students' activities.

The administration fee is \$170 and should be paid at once with the visa and stay permit fee

# ITS Administration Fee will be applied to cover some necessaries below:

- 1. Study Permit Letter
- 2. Residence Permit Letter
- 3. Police Notification Letter
- 4. Immigration Office Visit
- 5. Airport pick-up service
- 6. International student activities





# How to Apply for Visa

# **Documents & Fees**

Excep VoA & E-VoA, international students/faculty members are expected to provide all required documents for the intended visa application. The visa fee should be transferred to the person in charge at ITS.

# 02 Registration Process

ITS Global Engagement will apply for the visa based on the program type and also forward the payment to the Immigration Office of Indonesia

# **@3Visa Application**

After document validation and background checks. the immigration will issue the visa and IS Global Engagement will forward the visa to the students/faculty memberst

# **Q4Visa is Ready!**

Once visa is sent to the students/faculty members, they have to use the visa within 90 days since the date of visa issuance.



# Police Notification Report/Surat Tanda Melapor (STM)

Within the first 24-hours of your arrival in Indonesia, you must report to the nearest police station from your residential address to get an STM card

# Here are the requirements:

- A copy of your passport
- A copy of the KTP (Indonesian ID Card) of the host

# Proof of Residency /Surat Keterangan Tempat Tinggal (SKTT)

Within 14 days of your arrival, you must report to the Civil Registration Office to get a Proof of Residency

# Here are the requirements:

- Statement letter from RT and RW (Head of residence)
- Statement letter from Lurah (Head of village)
- Passport
- Temporary stay permit from immigration
- STM card
- Formal photograph

### NOTE:

BASED ON THE INDONESIAN LAW NUMBER 23, 2006, THE FAILURE OF HAVING PROOF OF

RESIDENCY IN 14 DAYS AFTER KITAS IS ISSUED WILL CAUSE A FINE OF IDR 2 MILLION.
