## **Notification of the Collection, Processing and Use of Personal Information of Examination Candidates by National Formosa University**

Pursuant to the “Personal Information Protection Act” (hereafter “the Act”) and in order to ensure the protection of your personal information, privacy and rights, please read in detail the following “Notification of the Collection, Processing and Use of Personal Information of Examination Candidates” formulated by National Formosa University (hereafter “the School”) according to Article 8 and 9 of the Act.

1. Agency (name): National Formosa University

2. Reasons for gathering personal information:

For performing the test service of the School’s admission test, the information (communication) and database management, the statistical research and analysis, and the relevant or required works of the student data management after the enrollment.

3. Way of gathering personal information:

The examination candidates’ personal information obtained via the personal delivery, the mail delivery, the fax or online registration.

4. Types of personal information gathered:

Include name, ID or ARC or Passport number, birthday, photo, gender, educational information, emergency contact person, address, email address, contact information, transfer account, proof of the low-income or the middle-low income family. The statutory types of personal information (Note) are: C001, C002, C003, C011, C021, C023, C033, C034, C038, C051, C052, C056, C057, C061, C062, C064, C072, C111, C132.

5. Handling and use of personal information:

(1) Utilizing period:

The utilizing period is the required duration of completing the aforementioned information gathering apart from the expiration date of the personal information for the tests conducted by the ordinance or the central division authority’s additional regulation.

(2) The region within which personal information will be used:

Taiwan (including Penghu, Kinmen and Matsu) or places where handling and use has been approved by the examination candidates.

(3) Users of personal information:

The units of the School and the relevant cooperative units of completing the aforementioned information gathering, including the Ministry of Education or other administrative, academic and research institutions.

(4) Way of using:

- a. The required exposure (announcement) based on the public trust of the test service, the academic research and other necessary methods for achieving the aforementioned collection objectives due to the School’s proceeding of the test

service, admitting, registering, approval, enrollment and students management, contacting the examination candidates (or parents and guardians).

- b. The School is allowed to provide the personal or relevant information to the related authority or judiciary by the regulation or the demand of the authority or judiciary by law.
6. The untrue, incorrect and incomplete personal information will cause the failure of registering the test, contacting for emergency, and delivering the grades, and that influence the examination candidates' rights of testing, follow-up test service and accepting the test service. The examination candidates should confirm all provided personal information to be true and correct. If there is any false or requiring alteration, please submit the relevant documentary identification to the Admissions Section, Office of Academic Affairs of the School for the application of correction.
7. In accordance with the Act, the examination candidates can inquire about the information or request to read it, ask for copies, supplement, correct, ask to cease the gathering, use and handling, and for deletion. The examination candidates can exercise the above rights by submitting a hard copy in writing, by fax and by phone with this request to the School (Please check the Registration Requirements for the contacting information). The request of ceasing the gathering, use and handling and for deletion must not obstruct the School's duty by law.

# National Formosa University 2026 Academic Year Fall Semester Enrollment Guide for International Students

## 1. Eligibility

**According to "National Formosa University Regulations Regarding International Students Undertaking Studies in Taiwan" (this Regulation), applicants who should meet both following requirements of identity and qualification:**

### (1) Nationality (Applicant's Identity)

According to International Students Undertaking Studies in Taiwan, Applicants must meet one of the following requirements in order to apply for admission as an international student in Taiwan :

1. Foreign nationals who have never acquired citizenship of the Republic of China (R.O.C) (note 1) and moreover have never studied with overseas Chinese status in Taiwan (note 2) and have not received the student status from the University Entrance Committee for Overseas Chinese Students in the enrollment year.
2. An individual of foreign nationality, pursuant to the following regulations and who has stayed overseas (including Mainland China, Hong Kong, Macau, and any other foreign countries) continuously for no less than 6 years (note 3), is also qualified to apply for admission under this regulation. (till August 1, 2026)
  - (1) The applicant has never had permanent residence and domicile in the R.O.C if he has acquired R.O.C citizenship upon application.
  - (2) The applicant has acquired R.O.C citizenship prior to application yet has legally divested from the R.O.C citizenship at least 8 years (till August 1, 2026) before the time of application.
  - (3) The applicant of both the above categories has never attended any academic institution in the R.O.C as an overseas Chinese and has never attended any overseas college entrance examinations.
    - ※ The application submitted by one who has both foreign nationality and R.O.C nationality, but who has already sent in application of his/her R.O.C. citizenship having been suspended for more than 8 years by making the due declaration to the Ministry of the Interior before February 1, 2011. Everything should be processed according to the original regulations. (i.e. not affected by the regulations of the preceding Paragraph)
3. An individual of foreign nationality who are Hong Kong or Macau Permanent Residents without household registration in Taiwan and has lived continuously overseas, in Hong Kong, or in Macau for over 6 years (note 3) at the time of application. (till August 1, 2026).
4. An individual that was once residents of Mainland China who is of foreign nationality without household registration in Taiwan and has lived continuously overseas for over 6 years (note 3) at the time of registration. (till August 1, 2026)

<p>【Note 1】</p>	<p>Article 2 of <a href="#">Nationality Act</a> of R.O.C.: Those who meet one of the following regulations should possess nationality of the Republic of China:          Biological father or mother has nationality of R.O.C. at the time of birth.          If born after the death of biological father or mother, by the time of his/her death, he or she is citizen of R.O.C.          Was born in the territories of R.O.C., when biological father and mother were either unidentifiable or stateless.          Has been naturalized.</p>
<p>【Note 2】</p>	<p>Overseas Chinese Students should apply to the University Entrance Committee for Overseas Chinese Student. According to Article 2 of <a href="#">Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan</a>, “The Overseas Chinese Students mentioned in the paragraph refers to overseas Chinese students who were born overseas and have resided continuously from birth to date, or have resided overseas continuously for the most recent 6 years, and possess permanent or long term residence permit. The recognition of overseas student’s status is notarized by the office handling overseas Chinese affairs.</p>
<p>【Note 3】</p>	<p>The term “overseas” means countries or regions other than Mainland China, Hong Kong, and Macau.  <b>The “six years” calculation means starting from the enrolled semester date as in August 1, 2026 to be the final date, and to push back six years (i.e. from July 31, 2020 to August 1, 2026)</b>          The term "continuously" means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year.          Should the calculation of continuous years living overseas start in an incomplete calendar year, the stay of each year in Taiwan must be below 120 days in order to be included. Individuals under one of the situations below and with related documents of proof may be excluded, the time resided in Taiwan will not be included in the count of overseas residence:          (1) Having studied at training sessions at Overseas Affairs affiliated institutes or professional training courses notarized by the Ministry of Education.          (2) Having studied at Ministry of Education approved Chinese Language Centers in colleges or universities for less than 2 years in total.          (3) Having been an exchange student for less than 2 years in total.          (4) Having had internships at Taiwan sanctioned central industry competent authorities for less than 2 years in total.</p>

⊙ Eligibility is based on MOE (Ministry of Education) [Regulations Regarding International Students Undertaking Studies in Taiwan](#). If there have been any changes or updates to the regulations, the latest version announced by the MOE prevails. For the latest information about MOE regulations, please contact the MOE.

## (2) Education Background

**Degree/Diploma: Applicants should meet one of the following criteria and qualified as one of the identities listed may apply for degree-seeking programs.**

- i. Graduates from a high school, university, or independent academy, which is recognized by the Ministry of Education, are eligible to apply for admission. (Please refer to the website of “[the Database for the Reference List of Foreign Universities](#)”)
- ii. Individuals with equivalent degrees stipulated in “[Standards for Recognition of Equivalent Educational Level As Qualified for Entering University](#)” by the Ministry of Education are eligible to apply for admission.
- iii. Academic credentials from Mainland China: The “[Regulations Governing the Accreditation of Schools in Mainland China](#)” shall apply.
- iv. Academic credentials from Hong Kong or Macao: “[Academic Credential Verification and Accreditation Methods adopted in Hong Kong and Macao](#)” shall apply.

- v. Academic credentials referred to the preceding 2 Items shall be subject to the “Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education.”

◎Undergraduate admissions

1. Foreign students holding a high school diploma are eligible to apply for the 4-year bachelor's, while those holding an associate degree diploma are eligible to apply for the 2-year bachelor's.
2. Sijil Pelajaran Malaysia (SPM) (or Form 5) students should have equivalent eligibility of a high school diploma to apply for undergraduate programs. Admitted applicants during their study are required to take additional courses for graduation (note).

Note :

Graduates of a school in a foreign country, Hong Kong, or Macau, who have been admitted to an undergraduate program based on their equivalent education level, i.e. second year of senior high school in Taiwan and the school from which they graduated is in the same category and at the same level as that in Taiwan, should take additional 12 graduation credits in accordance with the NFU regulations, in addition to completing the total graduation credits required by their departments. (Please refer to the website: <http://nfuaca.nfu.edu.tw/index.php/zh/2015-12-24-07-52-18>)

◎Graduate admissions

1. Foreign students with Bachelor's degrees are eligible for master programs; and those with master's degrees are eligible for doctoral programs.
2. Foreign students who have completed their bachelor's degrees (or above) in Taiwan and wish to apply for higher education are required to present their diplomas and official transcripts and follow the application procedure.

**(3) Further Explanation**

According to " Regulations Regarding International Students Undertaking Studies in Taiwan," Article 4 :

An international student applying to study at an educational institution in Taiwan in accordance with the provisions of the two previous articles is limited to only applying once. If a student wants to continue studying in Taiwan, their application shall be handled in the same manner as the admission procedures for domestic students.

An international student in any of the following circumstances, who after applying to study in Taiwan in accordance with the preceding paragraph, is applying to continue studying in Taiwan, or is once again applying to study in Taiwan, is not subject to the restriction set out in the preceding paragraph.

1. If the international student is applying for admission to a master's degree or higher-level program after completing the course of study at the educational institution to which they originally applied. The university to which the student is now applying shall handle the application in accordance with its regulations;
2. If the international student applied to come to Taiwan to undertake a bachelor's degree or lower-level program in Taiwan and after coming to Taiwan stayed for less than one year for some reason then discontinued their studies or forfeited their student status, that student may lodge another application to come to Taiwan to study, but only one such further application is permitted.
3. If the international student meets the requirements set out in the provisions of Article 2, Paragraph 1 and they are applying for admission to an associate degree program or a

program below that level.

4. If the international student meets the requirements set out in the provisions of Article 2, Paragraph 1 and they are applying for admission to a bachelor's degree program other than one in a university department of medicine, dentistry, or Chinese medicine; only one such further application is permitted.

If an educational institution in Taiwan where an international student was studying considers that their conduct or academic performance was unsatisfactory, or if the student seriously violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of its regulations governing student awards and penalties had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan on the basis of the provisions of the previous two paragraphs.

#### (4) Non-native Speaker Language Ability Requirements

Students who apply for a program that is taught in Chinese should be proficient in Chinese listening, speaking, reading, and writing; students who apply for a program that is taught in English should be proficient in English listening, speaking, reading, and writing. Applicants need to submit proof of language proficiency with their application.

Instruction for Submitting Language Proficiency Test Certificate are as follows:

- i. For programs taught in Chinese:

Students must have adequate listening, speaking, reading, and writing Chinese language skills. Documents or proofs of Chinese proficiency\*

Note1 : exemption : Applicants who are native speakers of the Chinese language or graduated from a school where Chinese is the language of instruction or the major in college used to be Chinese.

Note2 : Proofs of Chinese proficiency means any related documents which issued by institutes for Chinese proficiency test such as Test of Chinese as a Foreign Language (TOCFL) from Taiwan, Subject Test in Chinese with Listening (SAT) from United States, or certificates from Chinese courses of universities/colleges in Taiwan and so on.

Note3 : **For those applying for degree programs taught in Chinese, a photocopy of a TOCFL transcript or certificate for Level 2 or above. ( Registration System: <https://reg.sc-top.org.tw/register.php> )**

- **For other special regulations of specific departments please refer to the remark of “Departments and Graduate Institutes” for more information.**
- **Should the applicants meet the minimum language proficiency requirements, but fall short of the department's or graduate institute's requirements, the department or graduate institute committee reserves the right to reject admission, grant admission offer, or grant a conditional admission offer.**
- **If an international student accepts a Chinese conditional admission offer, he or she will have to obtain a Chinese proficiency certificate at the designated level or above in order to be accepted for enrollment. Enrollment will be cancelled if he or she fails to provide such documents.**

- ii. For programs taught in English:

Non-native English speakers must have adequate listening, speaking, reading, and writing English language skills. Proofs of Test of Proficiency- English\*

Note1 : exemption : Applicants who are native speakers of the English language or graduated from a school where English is the language of instruction.

- If an international student accepts an English conditional admission offer, he or she will have to submit an English proficiency certificate at the designated level or above in order to be accepted for enrollment. Enrollment will be cancelled if he or she fails to provide such documents.
- Only the language proficiency certificates listed above are accepted. Applications with certifications not included in this list will not be considered.

### 4. Application Method and Period (Taiwan local time GMT+8, **overdue will NOT be accepted.**)

#### (1) Application method

**Online application.** Please go to NFU “Online Application System for Foreign Student” (URL: <https://enrollstudents.nfu.edu.tw/signup/60008/0>) for registering application data and **uploading required documents** (refer to Attachment 2).

##### i. Online Registration System Login Portal:

- For 'First-time Applicants,' please click on the [First-time Registration] to begin your login.
- For 'Non-first-time Applicants (those who have not yet clicked [Confirm Submission]),' please click on the [Edit Registration Information] to log in.

※ We recommend using the Google Chrome browser. Mobiles and tablets are not recommended to log in to the system to avoid incomplete screen rendering that may affect your rights.

- ii. For this admission cycle, applicants may apply to a maximum of three departments. Applicants are required to indicate their department choices in order of preference, which will serve as the basis for admission decisions.
- iii. If an applicant is admitted to more than one choice, placement will be determined according to the order of preferences indicated in the application system.
- iv. If any disqualification conditions are found during the application review process or later, the application will be discarded and the applicant is not allowed to apply for any other programs.
- v. Applicants should provide the correct and exact name (same as passport) as well as a correspondence address to make sure a correct delivery of Letter of Acceptance. Otherwise, applicants shall be responsible for all the consequences caused.

#### (2) Application period:

**From 9:00AM on April 1, 2026 (Wednesday) to 12:00PM on May 13, 2026 (Wednesday). Late applications will not be processed.**

- i. The applicants are required to submit the completed application before by 12 pm on May 13, 2026(Wednesday). Late submissions will not be processed. All of the following required documents should be submitted at the same time via NFU “Online Application System for Foreign Student”.
- ii. The system will be open for 24 hours during the registration period. However, on the day of the deadline, it will close promptly at 12:00PM sharp. Please allocate sufficient time for uploading and completing the registration as early as possible within the deadline.
- iii. Applicants who upload their application documents or make payments after the deadline will be considered as not having completed the registration. Applicants

shall be responsible for the consequences and no objections will be accepted.

## 5. Application Fees and Methods of Payment

(1) Application fees:

**NT\$1,000 or US\$40 per person. (maximum 3 departments, associated remittance fees are included in)**

**Please remit Application fee to NFU account before by 5:00PM on May 13, 2026.**

- i. **The application fee is non-refundable under any circumstances, including cases of incomplete applications, cancelled applications, ineligible applications, late applications, overpayment, double payment, mistaken payment and etc.**
- ii. **Applications will not be processed if the application fee is not paid by the deadline.**

(2) Methods of Payment:

- i. The application fee can be paid via bank transfer, credit card, or in cash at the NFU Division of Cashier (Administration Building, 1st floor). **Please enclose a copy of Bank Telegram Transfer receipt or any other payment receipt. Please note that any remittance fees must be covered by the applicants. (※Important: Do NOT send cash or banknotes by mail.)**
- ii. **The applicant's name must be shown as the remitter on the remittance form even if the payment was not made by the applicant.**

- (3) Foreign students who have been forced to drop out at any institution in Taiwan due to their behavior problems, failed academic performances and criminal records are not allowed to apply for admission. Should any of the above violation cases be verified, the applicant's student status will be revoked immediately.
- (4) **Foreign students who have the household registration, naturalization or restoration to R.O.C. nationality during your study have to lose your foreign students status and accept the discontinuation of your study by the University.**
- (5) **According to regulation issued by Taiwan Ministry of Education, applicants should present NFU a valid medical insurance of 6 months started from the date of entering Taiwan.**

- (2) Retaining Admission:  
**If you are prevented from enrolling for reasons such as illness, pregnancy, childbirth, taking care of a child under 3 years old, or other exceptional circumstances, you may submit relevant documents and apply to retain your admission status for up to one year. Under special circumstances, you may be able to apply to retain admission status for one additional year afterwards. If you would like to retain your admission status, please submit a written application along with your academic documents to the Office of Academic Affairs before the first day of class specified in the academic calendar; no fee is required.**
