- 1. Decree of the Head of National Disaster Management Agency Nr. 13.A Year 2020 on the Extension of Emergency Status of Certain Circumstances for Disease Disaster as a Result of Corona Virus in Indonesia;
- 2. Decision of East Java Governor Nr. 188/108 / KPTS / 013/2020 on the Emergency Status of Disease Disaster as a Result of Corona Virus in East Java; and
- 3. The results of coordination meeting by ITS Management dated on March 23, 2020.

#### ITS Rector takes on policy as follow:

- Reaffirming the circular letter of ITS Rector Nr. T/21018/IT2/TU.00.08/ 2020 on Prevention of Covid- 19 Spread at ITS, that all forms of learning activities and examination shall be implemented by existing online platforms such as MyITS Classroom, e-Learning, or other means. If the substance of learning is not possible to be conducted by online, it can be implemented with other relevant forms.

For budget and cost consequences of the setting should refer to the current rules, or could be set later in other regulations.
- 4. The implementation of online learning and WFH is extended until the end of this semester (even semester), academic year 2019/2020. Periodically, Management of ITS will evaluate the above policy based on the latest update of situation.
